PARIS, 7th March 2023 – LeadCrest Capital Partners ("LeadCrest"), **the first European fund 100% dedicated to sale-leaseback and build-to-suit investments**, today announced entering a partnership with Landsforeningen Autisme on behalf of AkademikerPension, aiming to develop new residences for the association, and a first DKK 130 million pilot project in Lejre, Hvalsø.

<u>Highlights</u>



An established organisation: Founded in 1962 by a group of parents, Landsforeningen Autisme is a nonprofit, state-funded organisation that aims to spread knowledge of autism and understanding of the difficulties that autism entails. The organisation has approximately 13,000 members and contributors relying on a network of 16 centres across Denmark.

A strategic partnership: the partnership between Landsforeningen Autisme and AkademikerPension aims to position Denmark as a pioneer for building residences dedicated to people diagnosed with

autism. More specifically, it targets to develop up to 10 new care homes for a total of up to DKK 1 billion. The first project is Ny Højtoft in Hvalsø, for which Landsforeningen Autisme will commit to a 30-year lease upon completion.

A state-of-the art facility: The development site is located in Lejre, Hvalsø, and will comprise 4,470 square metres with a capacity of up to 46 residents. Construction works will start on 9th March 2023 and are set to complete in Q2 2024.
